In consideration of my (our) use of Indianfields Township Park, I (we) hereby release and covenant not to sue Indianfields Township, Indianfields Township Board of Trustees, and/or any of their employees or agents from any and all present and future claims resulting from ordinary negligence on the part of Indianfields Township and/or others listed for property damage, personal injury, or wrongful death arising as a result of my (our) using Indianfields Township Park incidental thereto; wherever, whenever, however the same shall occur.

I (we) understand that this waiver is intended to be as broad and inclusive as permitted by the laws of the State of Michigan and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I (we) further agree that the venue for any legal proceeding shall be in the State of Michigan.

I (we) affirm that I (we) am of legal age and am freely signing this agreement. I (we) have read this form and fully understand that by signing this form, I (we) am giving up my (our) legal rights and/or remedies which may be available to me (us) for any ordinary negligence of Indianfields Township or any of the parties listed above.
