Public Comment:

Norm Stevens- Almer Township Wind Ordinance Draft that was approved by planning Commission- Campbell - Thinks it has been approved but **not** presented to the Board yet- Stevens- has concerns over this section

Briana- Caro Baseball/ Softball- Sent all documents @ 4:40 pm 501c3 /other letters/ She needs a Resolution as of the time of meeting no one has seen the letter-

Mark Strzelewicz- After the Public Hearing of the Master plan each member should read the Master Plan there are several concerns to look at to make the document better- Moratorium that effects wind energy

Laura Strzelewicz- Concerns about last summer- very 1st time herbicide was along the creek- now some soil erosion and decrease number of frogs- Trails are nice but they are becoming muddy due to trees being removed and no leaves to cover trail

Sauber- Indianfields Township cannot currently have wind Turbines because of the airport- Campbell agreed that due to airport zoning Indianfields cannot allow wind turbines.

Jim Tussey- Tuscola airport authority- regarding the Township master plan- looking for us to consider changing the SW zoning map/ concerns over Industrial vs. Ag & forestry concerns over the switching and the proposed ordinances –If the airport does disband the current zoning does not protect the land from wind turbines concerns over setbacks and heights of wind turbines- in comparison of residents and lot lines- T.C. airport is still in litigation it set the Township up for an unsafe master plan and ordinances in a uncharted territory we need to relook @ Township zoning and the zoning administrator due to this master plan being not resident friendly and wind turbine pro- Sauber- called a halt to the path that was being taken- stated they will look again at the zoning and master plan

Agenda- Campbell motion by Osborn as written 2nd by Sauber- Campbell would like to make additions – Lengthy discussion ensued: Sauber asked for the items Campbell would like added- Campbell- Roads Contract/ Budget/ planning commission appointments- 5th Call out from Smith for the motion on the floor Campbell will not call the Vote he wants to add his items- 6th call out for motion on the floor from Smith- 7th call out from Smith for motion on the Floor to accept the Agenda as presented- exchanges from the Board were that there were 6 days to present items before the meeting to add agenda items/ previous meeting approved items must be submitted prior to any meeting for the Board has a chance to prepare for meetings-Campbell is going to tell THE CLERK

“Young Lady and explain to me one last time I want my items added” – Osborn called a “point of Order” call for a vote on the motion- Campbell- Will not move forward- Smith you had 6 days’ notice to add items to the agenda- Sauber asking again what he wants added- Campbell- asking Sauber what does he not understand?- Sauber stated the Board has approved His budget Campbell stated how could we , he did not give out his budget? Sauber said he has his budget- Smith stated she has his budget so did R. Osborn & K. Osborn Campbell asked where we got his budget? Smith stated from the \$1300 of ads he ran in the advertiser- Osborn withdrew his motion to approve the agenda and moved to adjourn 2nd by Smith 1 call to Vote- Campbell stated he is being blocked by the Township Sauber added he is not being blocked there is a motion- Osborn asking since there is no agreement to call a Special and put together an agreeable agenda Mr. Campbell either approve the agenda or adjourn- Campbell add his items to the agenda or we are not moving forward- Smith stated that this is the second meeting he has been in attendance at and we are not moving forward and the other one he walked out on- Campbell called Smith a Liar Smith asked him if he was calling the Clerk a Liar- Campbell “if the shoe fits” Sauber apologized to the public- Osborn- Mr. Campbell you succeeded in disrupting the public again- Smith- Call to Vote motion to adjourn- Smith- Mr. Campbell- No response- Smith- Roll call to see who was left on the call: Sauber- R. Osborn- K. Osborn- Campbell there was no response by any of the Board

Smith: In my five years on the Board this has not happened, not to sure how to proceed called out for Public Comment: None
