Chippewa Heights Condominium has been deemed complete by Developer

Robert Buchinger and accepted as such by this Board (Planning Commision). Developer has surveyed

the property, separating the developed, completed parcel from the undeveloped

parcel and has placed the undeveloped parcel for sale. The listing agent has

been uncooperative in acknowledging Arrowhead Drive as a private drive.

The township assessor has given the undeveloped parcel its own tax I.D. number

013-002-300-1200-00, combining parcels 013-002-325-0700-00, 013-002-325-0800-00, 013-002-325-0900-00, 013-002-325-1000-00, 013-002-325-1100-00, 013-002-325-1200-00 on 5/16/25. However, 013-002-300-1200-00 still appears in the Tuscola County GIS with a property address as V/L Arrowhead Dr, Caro. The survey clearly shows Arrowhead Drive remains with the developed condominium project and Arrowhead Drive is private drive. The undeveloped parcel fronts on Weeden Road. I spoke with the Tuscola County Treasurer on June 3rd and she stated we need to direct the township assessor to have Tuscola County Equalization change the address to V/L Weeden Rd, Caro. This will help to ensure that any buyer will not be misled to believe that Arrowhead

Drive is for use of the undeveloped parcel.

2025 Free Tire Collection to be held June 21, 2025, at Indianfields Township Park from 8 AM to 2:30 PM, Open to Tuscola County Residence.

Bathrooms at the Park, Getting an estimate from Utley to get them operating again to save on port-a-jon costs.

Handbook, Tabled for future meeting Tess/Eric to review and present changes as well as input from our attorneys.

Cameras at the Hall/Cemetery (fuel), Looking into options to have cameras installed. Carmen Stevens from Wells Township suggested Honor Security Service out of Saginaw. They installed Wells Township's system.

Ron Woloshen will attend the meeting on the Dam on June 10, 2025 and report back.

Caro Fire Department will operate as normal despite staff losses.

Jane Gimmel, 1555 Boy Scout Road, concerned about shooting range. Advised that the Township does not have jurisdiction and that complaints regarding dangerous issues need to be filed with the Police/DNR as appropriate. Also concerns about blight at a different neighbor's, instructed to file a written complaint with the Enforcement Officer.
