December 12, 2014**

An ordinance to protect the public health, safety and general welfare by establishing regulations relating to the operation, control, and management of cemeteries owned by the Township of Indianfields, Tuscola County, Michigan; to provide penalties for the violation of said ordinance, and to repeal all ordinances or parts of ordinances in conflict therewith.

The Township of Indianfields, County of Tuscola Ordains:

**Section 1: Title:**

This ordinance shall be known and cited as the Indianfields Township Cemetery Ordinance.

**Section 2: Definitions of cemetery lots and burial spaces:**

A cemetery lot shall consist of burial spaces sufficient to accommodate from one to six burial spaces. An adult burial space shall consist of a land area forty (40) inches wide and ten (10) feet in length. An infant or stillborn burial space (in Babyland) shall consist of a land area three (3) feet wide and three and one-half feet (3 ½) feet in length in areas set aside specifically for such burials.

**Section 3: Sale of lots or burial spaces:**

Hereafter, cemetery lots or burial spaces shall be sold only to residents or taxpayers of the township for the purpose of burial of such purchaser or his/her heirs at law or next of kin. No sale shall be made to funeral directors or others than as heretofore set forth. The township Clerk OR DESIGNEE AND SUPERVISOR OR DESIGNEE, (Revision 12/12/2014) however, is hereby granted the authority to vary the aforesaid restriction on sales where the purchaser discloses sufficient personal reason for burial within the township through previous residence in the township or relationship to persons interred therein. Crypts and niches in the mausoleum shall be exempt and will be sold according to the fee schedule as set by the Indianfields Township Board AT THE NON-RESIDENT RATE. (Revision 12/12/2014)

Sales of lots or burial spaces shall be in accordance with the fee schedule set by the Indianfields Township Board. All such sales shall be made on a form (Cemetery Lot Certificate) approved by the township board, which grants a right of burial only and does not convey any other title to the lot or burial space sold. Such Certificate shall be executed by the office of the township clerk and signed by the cemetery superintendent, the township clerk and the township supervisor.

Burial rights may only be transferred by private individuals through inheritance as next of kin or through approval by THE CLERK OR DESIGNEE AND SUPERVISOR OR DESIGNEE, (Revision 12/12/2014) upon request of original owner(s) to other family members. Such transfers shall be recorded in the official cemetery records and a new cemetery lot certificate shall be issued. Burial rights, lots, or spaces may not be transferred from one private individual to another or sold by one private individual to another. Individuals may sell unused spaces back to Indianfields Township for the original price of purchase. Indianfields Township will NOT recognize any transactions of sale or transfer of burial rights made between private individuals and such transactions shall NOT be recorded in the official cemetery records.

**Section 4: Purchase Prices and Transfer Fees:**

Each burial space or entombment space shall be priced according to the fee schedule as set by the Indianfields Township Board and reviewed on an annual basis. The board may periodically alter the foregoing fees to accommodate increased costs and needed reserve funds for cemetery maintenance and acquisition. The foregoing charges shall be paid to the cemetery superintendent, forwarded to the township treasurer and shall be deposited in a designated township account.

A deposit of 50% of the total purchase value is required at the time of purchase with six (6) months allotted to pay the remaining balance interest free. After six (6) months, interest at the rate of 1 ½% per month on the outstanding balance shall be added. Any spaces not paid in full at the end of one year shall revert back to the township. Deposits made for unused spaces shall be refunded to the purchaser.

Spaces may not be "held" or reserved without a monetary deposit.

A burial space, crypt or niche must be paid for in full before burial/entombment can take place.

A Cemetery Lot Certificate for right to bury is issued only when the space(s) are paid for in full.

If an individual purchases a space or spaces as a non-resident and then later becomes a township resident and or taxpayer/landowner, no refund of the original purchase price will be made.

When spaces are purchased by more than one individual, each person's interest in the lot shall be specifically stated.

A copy of this ordinance shall be provided to all individuals at the time of purchase.

**Section 5: Grave opening charges:**

The opening and closing of any burial space, prior to and following a burial therein, and including the interment of ashes shall be as according to the fee schedule established by the Indianfields Township Board.

No burial space shall be opened and closed except under the direction and control of the cemetery superintendent. The removal and reinterment of bodies and remains shall be under the control of the cemetery superintendent, under the direction of a licensed funeral director and require the appropriate permit from the local health department.

Graves cannot be opened for inspection without the appropriate legal documentation.

**Section 6: Markers and Memorials:**

All markers or memorials must be of stone or other equally durable composition. Any exceptions must be authorized by the cemetery superintendent. Any markers or memorials made of materials that have rotted, decomposed or otherwise become unsightly will be removed at the discretion of the cemetery superintendent.

All monuments must be located upon a suitable foundation made of concrete to maintain the monument in an erect position and assist with grounds maintenance. All foundations are to be poured by cemetery staff or designee of the cemetery superintendent and will be poured to a standard pre-formed size unless special accommodations are made at the discretion of the cemetery superintendent.



Markers and memorials may not be of a size that encroaches upon adjoining lots belonging to others. It shall be the responsibility of the individual purchasing the marker to assure that it is the appropriate size.

Markers and memorials may not contain inscriptions that are deemed vulgar, offensive, or improper. Any markers in violation of this shall be removed and replaced at the owner's expense.

**Section 7: Interment Regulations:**

One burial space may contain one full burial, one full burial and one cremation/infant burial, or two cremation/infant burials. Mausoleum crypts and niches can accommodate one to two caskets or additional cremation containers dependent upon the size of the individual crypt/niche.

Not less than 36 hours notice shall be given in advance of any time of any funeral to allow for the opening of the burial space except in extenuating circumstances such as non-embalmed decedents, etc., where the law or religious practices require immediate burial.

There will be no burials on Sundays or major holidays except in extenuating circumstances such as religious practices or compliance with state or local regulations pertaining to interment of non-embalmed human remains. \*A major holiday is defined as the holiday itself and/or any day that the township offices are closed in observance of a holiday in accordance with the holiday schedule in the Indianfields Township Personnel Policy/Employee Handbook." (Revision adopted 2/14/05)

\*The use of the cemetery chapel/committal building shall be done BY reservation only. (Revision adopted 2/14/05) CHAPEL MAY BE CLOSED DECEMBER 1<sup>ST</sup> TO APRIL 1<sup>ST</sup>. ( Revision 12/12/2014)

The appropriate burial/transit permit for the individual being interred shall be presented to the cemetery staff prior to interment. Families burying cremains must obtain the proper permit from the funeral home or crematory if they do not possess the original burial/transit permit.

All graves shall be located in an orderly and neat appearing manner within the confines of the burial space involved.

No lot or space may be used for any other purpose than the burial of human remains.

**Section 8: Grounds Maintenance:**

No grading, leveling or excavating upon burial space shall be allowed except by cemetery staff.

No flowers, shrubs, trees or vegetation of any type shall be planted without the approval of the cemetery superintendent. Any of the foregoing items planted without such approval may be removed by the township or the cemetery staff.

The cemetery superintendent reserves the right to remove or trim any tree, plant or shrub located within the cemetery in the interest of maintaining proper appearance and the use of the cemetery including those that obstruct adjoining burial spaces or encroach upon adjoining lots belonging to other individuals.

All mowing of lots is to be done by the cemetery staff based upon an established maintenance schedule.

Seeding of lots is done in the spring and in the fall as these times represent the most ideal conditions for growing grass. Requests for seeding and watering in excess of this schedule may be made to the cemetery superintendent and will be charged for in accordance with the established fee schedule.

Cemetery staff reserve the right to remove any items interfering with normal grounds maintenance.

Mounds which hinder the free use of a lawn mower or other gardening apparatus are prohibited.

The cemetery staff shall have the right and authority to remove and dispose of any and all growth, emblems, displays or containers therefore that through decay, deterioration, damage or otherwise become unsightly, a source of litter, or a maintenance problem.

Surfaces other than sod and earth are prohibited.

Paving bricks, edging, coping, fencing, decorative rocks, stones, benches, etc., are not allowed until special permission has been given by the cemetery superintendent. Any of these items placed without authorization may be removed without notice.

#### **Section 9: Grave Decorations:**

Indianfields Township Cemetery staff and/or township board members are NOT responsible for any items used as grave decorations and shall not be liable in any way for replacing decorations damaged, stolen or in any other manner disturbed.

Grave decorations that are deemed offensive, or those that obstruct the ability of cemetery staff to conduct burials or grounds maintenance may be removed by cemetery staff.

Alcohol, tobacco products, weapons of any kind, or illegal substances may not be used as grave decorations and will be removed.

Individuals may not place grave decorations or other items in the aisles, on burial spaces belonging to other individuals, or elsewhere on the township cemetery grounds not intended for use for burial.

Winter decorations and grave blankets must be removed by April 1<sup>st</sup>. Any such decorations remaining after April 1<sup>st</sup> shall be removed and destroyed.

#### **Section 10: Veterans:**

Grave flags shall be placed on the graves of veterans each Memorial Day. The Indianfields Township Board shall pay the cost of the flags and the cemetery staff shall place them on the graves. The flags will be replaced throughout the year upon request if they are lost or damaged.

Veterans who do not own burial rights in any spaces and are residents of Indianfields Township may be buried in the township's "Veteran's Section" (Block 18). Normal grave opening and closing fees will be assessed at the time of burial.



**Section 11: Mausoleum Storage:**

Indianfields Township Cemetery shall store in the Mausoleum, at the request of funeral homes, individuals intended for burial and for whatever circumstances cannot be immediately interred. Families of these individuals must sign an agreement to hold Indianfields Township Cemetery harmless in the event of any damages and release Indianfields Township Cemetery from any liability associated with this storage. A fee for storage shall be assessed based upon the fee schedule established by the Indianfields Township Board and funeral homes will be responsible for payment.

**Section 12: Vaults:**

All full body burials in the ground shall be within a standard concrete vault installed or constructed in each burial space before interment. Cremains shall be placed within appropriate containers. Caskets being entombed in the Mausoleum do not require a vault.

**Section 13: Forfeiture of Vacant Lots/Reclaiming of Lots:**

Cemetery lots or burial spaces sold after the effective date of this ordinance and remaining vacant 40 years from the date of their sale MAY (Revision 12/12/2014) automatically revert to the township upon occurrence of the following events:

1. Notice shall be sent by the township clerk by first class mail to the last known address of the last owner of record informing him/her of the expiration of the 40 year period and that all rights with respect to said lots or spaces will be forfeited if he/she does not affirmatively indicate in writing to the township clerk within 60 days from the date of mailing of the within notice his/her desire to retain said burial rights.
2. No written response to said notice indicating a desire to retain the cemetery lots or burial spaces in question is received by the township clerk from the last owner of record of said lots or spaces, or his heirs or legal representative, within 60 days from the date of mailing of said notice.

Indianfields Township also reserves the right to reclaim burial rights for any block, lot or burial space that currently remains unused for a period of FORTY (40) years SUBJECT TO THE PREVIOUS NOTED EVENTS IN SECTION 13 #1. AND #2. (Revision 12/12/2014)

**Section 14: Repurchase of lots or burial spaces:**

The township will repurchase any cemetery lots or burial space from the owner for the original price paid the township upon written request of said owner or his legal heirs or representatives.

**Section 15: Records:**

The cemetery superintendent shall maintain records concerning all burials. The cemetery records shall be open to public inspection and are subject to the Michigan Freedom of Information Act.

**Section 16: Rules of Conduct:**

Young children must be supervised by a responsible adult while on the cemetery grounds.

Smoking within any township owned building is prohibited.

All trash and refuse must be disposed of in the proper waste receptacles.

Automobiles within the cemetery shall not travel at speeds in excess of ten miles per hour.

Automobiles must not park in roadways and otherwise block traffic flow within the cemetery.

Bicycles, skateboards, and rollerblades are prohibited in the cemetery.

No unlicensed motorized vehicles (e.g. four-wheelers, ATV's, golf carts, etc.), except those intended as mobility aids for persons with physical handicaps, are allowed on the cemetery grounds except those designated as cemetery maintenance vehicles.

Peddling or soliciting goods is prohibited.

No firearms are allowed in the cemetery with the exception of the veterans who perform the Memorial Day and military funeral services.

No signs or advertisements are allowed in the cemetery except those placed by cemetery staff.

**Section 17: Cemetery Hours:**

The cemetery shall be open from the hours of 7:00 a.m. to 10:00 p.m. each day. No person shall be permitted in the township cemeteries at any time other than the foregoing hours, except upon permission from the cemetery superintendent or the Indianfields Township Board.

**Section 18: Penalties:**

Any person, firm or corporation who violates any of the provisions of this cemetery ordinance shall be guilty of a misdemeanor and shall be subject to a fine of up to \$100.00 and/or imprisonment for up to 90 days in jail as may be determined by a court of competent jurisdiction. Each day that a violation continues to exist shall constitute a separate offense. Any criminal prosecutions hereunder shall not prevent civil proceedings for abatement and termination of the activity complained of.

**Section 19: Severability:**

The provisions of the within ordinance are hereby declared to be severable and should any provision, section or part thereof be declared invalid or unconstitutional by any court of competent jurisdiction, such decision shall only affect the particular provision, section or part thereof involved in such decision and shall not affect or invalidate the remainder of such ordinance which shall continue in full force and effect.

**Section 20: Effective Date:**

This ordinance shall take effect on December 24, 2004. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Notice shall be sent by the township clerk by first class mail to the last known address of the last owner of record informing him/her of the expiration of the 40 year period and that all rights with respect to said lots or spaces will be forfeited if he/she does not affirmatively indicate in writing to the township clerk within 60 days from the date of mailing of the within notice his/her desire to retain said burial rights.

No written response to said notice indicating a desire to retain the cemetery lots or burial spaces in question is received by the township clerk from the last owner of record of said lots or spaces, or his heirs or legal representative, within 60 days from the date of mailing of said notice.

Indianfields Township also reserves the right to reclaim burial rights for any block, lot or burial space that currently remains unused for a period of fifty (50) years.

**Section 14: Repurchase of lots or burial spaces:**

The township will repurchase any cemetery lots or burial space from the owner for the original price paid the township upon written request of said owner or his legal heirs or representatives.

#### **Section 15: Records:**

The cemetery superintendent shall maintain records concerning all burials. The cemetery records shall be open to public inspection and are subject to the Michigan Freedom of Information Act.

#### **Section 16: Rules of Conduct:**

Young children must be supervised by a responsible adult while on the cemetery grounds.

Smoking within any township owned building is prohibited.

All trash and refuse must be disposed of in the proper waste receptacles.

Automobiles within the cemetery shall not travel at speeds in excess of ten miles per hour.

Automobiles must not park in roadways and otherwise block traffic flow within the cemetery.

Bicycles, skateboards, and rollerblades are prohibited in the cemetery.

No unlicensed motorized vehicles (e.g. four-wheelers, ATV's, golf carts, etc.), except those intended as mobility aids for persons with physical handicaps, are allowed on the cemetery grounds except those designated as cemetery maintenance vehicles.

Peddling or soliciting goods is prohibited.

No firearms are allowed in the cemetery with the exception of the veterans who perform the Memorial Day and military funeral services.

No signs or advertisements are allowed in the cemetery except those placed by cemetery staff.

#### **Section 17: Cemetery Hours:**

The cemetery shall be open from the hours of 7:00 a.m. to 10:00 p.m. each day. No person shall be permitted in the township cemeteries at any time other than the foregoing hours, except upon permission from the cemetery superintendent or the Indianfields Township Board.

#### **Section 18: Penalties:**

Any person, firm or corporation who violates any of the provisions of this cemetery ordinance shall be guilty of a misdemeanor and shall be subject to a fine of up to \$100.00 and/or imprisonment for up to 90 days in jail as may be determined by a court of competent jurisdiction. Each day that a violation continues to exist shall constitute a separate offense. Any criminal prosecutions hereunder shall not prevent civil proceedings for abatement and termination of the activity complained of.

#### **Section 19: Severability:**

The provisions of the within ordinance are hereby declared to be severable and should any provision, section or part thereof be declared invalid or unconstitutional by any court of competent jurisdiction, such decision shall only affect the particular provision, section or part thereof involved in such decision and shall not affect or invalidate the remainder of such ordinance which shall continue in full force and effect.



**Section 20: Effective Date:**


This ordinance shall take effect on December 24, 2004. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
